LRMT Training Program – Application Overview

Because of the volume of applicants and inquiries, we are unable to make exceptions to our program requirements. Please note that this pamphlet is intended solely as an overview; the official LRMTTP Manual shall prevail. Following the application instructions and sending a well-organized application are requirements for acceptance into the program.

Eligibility Requirements

All requirements must be met before applying

Teaching Credentials

- At least 21 years of age
- Has served as a Reiki Master Teacher for **at least 2 years** and has taught **at least 8 classes**
- Currently conducting **at least 10 Reiki sessions per month**
- Has been a **Professional Member** of the Reiki Membership Association (RMA) for **at least 1 year**

ICRT Training Completion Requirements

- Completed the latest version of ICRT Usui/Holy Fire® **Reiki I & II** with an LRMT
- Completed the latest version of ICRT Usui/Holy Fire® **Reiki Master** with an LRMT
- Completed the latest version of ICRT Holy Fire® **Karuna Reiki® Master** with an LRMT
- Attended online or in-person **International Reiki Retreat** and Licensed Teacher Meeting
- Completed Holy Fire® III **online training** with ability to teach online

Professional Ethics & Values

- Maintains clean, appropriate appearance and conduct in all professional activities
- Maintains a respectful attitude on social media and all online platforms
- Agrees with and adheres to ICRT philosophy, mission, and code of professional ethics

I Application Process Overview 7 Steps

1 Program Questionnaire

- Complete the LRMT Program Questionnaire via Google Form to confirm basic eligibility
- Pay \$100 administrative fee (contact Tammy@reiki.org)
- Wait for ICRT response to confirm whether invited to proceed to the formal application stage

2 Submit Application Documents

- Submit letter of intent, enrollment application, and applicant agreement (via Google Forms)
- Email copies of all Reiki certificates and a personal photo
- Pay non-refundable \$500 application fee (valid up to 1 year); must be completed within 5 months of questionnaire submission

3 Letters of Recommendation

- Employer x1
- Students x5 (joint application: x3 each)
- All ICRT LRMT teachers from whom you have taken courses
- Personal reference x1
- Clients x3 (joint application: x2 each)

4 Business Competency Assessment

- Complete business competency assessment Google Form
- Assessment areas: business organization & management, marketing, technology, teaching ability, practice ability, and success mindset

5 Psychological Assessment Interview

- Approximately one-hour interview with a licensed psychologist
- Questions provided in advance; scheduled near the end of the application process

6 Background Check & Credit Review

- Background check and credit review conducted by the ICRT office

7 Submit Application Documents

- Program co-directors conduct a comprehensive review of all materials and references
- Notified of application result upon completion of review
- Upon acceptance, assigned a mentor and officially enrolled in the LRMT Training Program

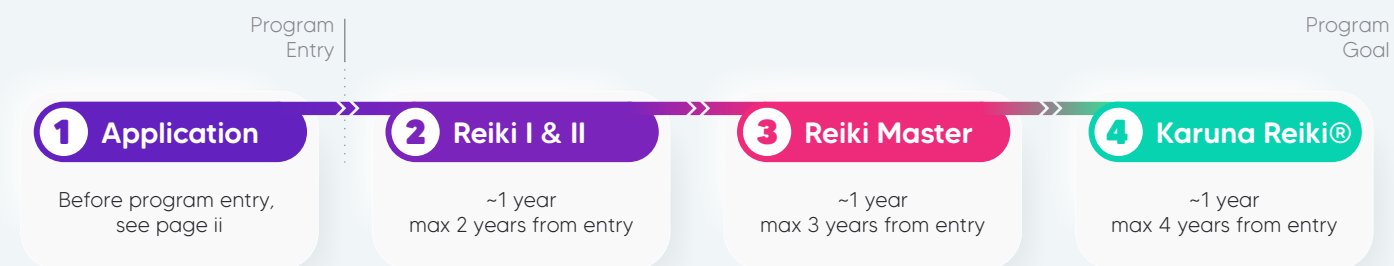

LRMT Training Program Pathway – Complete Stage Guide

Four stages to become a fully licensed Holy Fire® III Karuna Reiki® Master Teacher. The full program requires approximately 1,000 hours of study and practice, typically taking 3–4 years. All levels must be completed within 4 years of acceptance.



Ongoing Requirements – Active Throughout ALL Stages

Teaching Requirements

- Teach **6** Reiki I & II classes
- Total **18+** students
- Complete paperwork for **6** classes (accurately for at least **4** out of **6**)
- Animal Reiki option: count up to **2** classes and **6** students from Animal Reiki I & II

Practice & Assessment

- Complete **100** Reiki treatments within the program (**45+** min each; **10+** self-sessions)
- 5** different clients submit Client Review Forms
- Pass written test with **85+%** score (1 month before co-teach)
- Write a Reiki paper of **1,500–2,000** words on a Reiki topic of your choice

Final Steps: Review & Co-Teach

- Review a Reiki I & II class with Mentor (pay full tuition; remain in student role)
- Sponsor a Reiki I & II class and co-teach it with Mentor (minimum 8 students)
- Student Teacher is considered licensed when all fees are paid
- Submit Mentor-Student Tracking Form for Reiki I & II to Mentor and Program Directors
- Sign the Professional Contract

- Teach **3** Reiki Master classes
- Total **9+** students

 Animal Reiki option: count up to 1 class and 3 students from Animal Reiki Master



Karuna Reiki® teaching:

- Teach **3** Karuna Reiki® Master classes
- Total **9+** students

Final Steps: Review & Co-Teach

 Review a Karuna Reiki® Master class with Mentor (pay full tuition; remain in student role)

 Re-take the symbols test and submit as proof of review

 Sponsor or co-teach a Karuna Reiki® Master class with Mentor Teacher (min. 4 students, 8 if mentor has to travel)

 LRMT is considered licensed for Karuna Reiki® Master when all fees are paid

 Submit Mentor-Student Tracking Form for Karuna Reiki® Master to Mentor and Program Directors

Outcome: Become a Fully Licensed ICRT Holy Fire® III Karuna Reiki® Master Teacher

I STAGE 2: Reiki I & II Requirements

To Teach Usui/Holy Fire® III Reiki I & II As a Licensed Reiki Master Teacher

Administrative Requirements Monthly, Ongoing



Pay Monthly Administrative Fee

Individual \$200/month • Partners \$300/month

Pay a monthly tuition/administrative fee of \$200 to the ICRT Licensing Program as a Student Teacher for Reiki I & II. For partners, the fee is \$300.



Meet with Mentor Teacher Monthly

2 hours/month • By phone or online

Discuss your progress in the program as well as one or more of the following: business comprehension and organization, technology, marketing, practitioner skills, teaching skills, healing issues that arise, or success consciousness. If more mentoring time is desired and agreed upon by the mentor and student teacher, the student teacher will pay the mentor directly at the ICRT rate for mentoring, prorated by time.



Submit Mentor-Student Tracking Form for Reiki I & II

Monthly to Mentor Teacher • Quarterly to Program Director • by 10th of month

Complete the Mentor-Student Tracking Form for Reiki I & II and send it to your Mentor Teacher monthly and the Program Director quarterly by the 10th of the month. Prior to your co-teach, send the form to the Program Directors so they can verify you have met all requirements.



Submit Progress Report

Quarterly • by 10th of month • to Mentor Teacher and Program Directors

Complete the Progress Report quarterly and send it to your Mentor Teacher and Program Director by the 10th of the month.

Teaching Requirements During first year after acceptance into the program



Teach 6 Reiki I & II Classes

6 classes • minimum 18 students total (average 3 per class)

Teach 6 Reiki I & II classes, with a minimum average of 3 students each for a total of 18 or more students during the first year after acceptance into the program. Partners can teach separately or together; each must teach 6 classes with 18 students. In co-taught classes, each teacher will count the class and the students.

ICRT symbol tests and completed Class Reviews – with the student's name and contact number, and their consent to be contacted by ICRT staff – must be submitted to your Mentor.

If teaching ICRT Animal Reiki, you may count up to 2 classes and 6 students from Animal Reiki I & II classes.



Complete paperwork for each class

Accurately for at least 4 out of 6

Complete the paperwork for each class accurately for a minimum of 4 of the 6 classes taught.

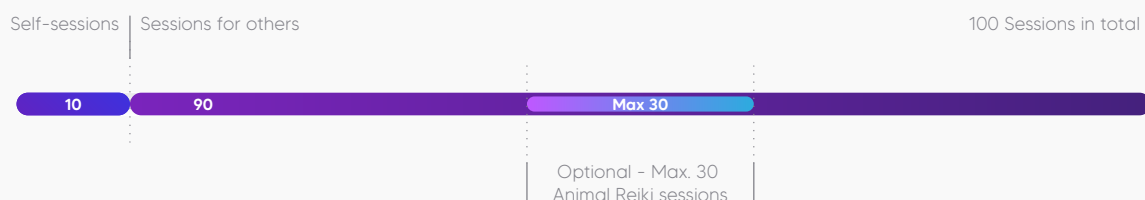
Session Requirements After acceptance into the LRMT program



Complete 100 Reiki Treatments

100 sessions • minimum 45 minutes each

Submit documentation of each using the ICRT Reiki Treatment Documentation Form. "Complete" is defined as at least a 45-minute session for an individual or a group with Usui/Holy Fire® III Reiki. Treatments may also include the Healing Experience, other Experiences in the manuals, and Karuna Reiki®. A minimum of 10 must be self-sessions. Out of the remaining 90, up to 30 may be animal Reiki sessions (which may be shorter than 45 minutes and can include the caregiver). Send completed forms monthly to your mentor.



Collect 5 Client Reviews

5 different clients • via Google form

Have 5 different clients submit reviews of the Reiki treatment they received from you. Ask the Program Director for the link to the Google form.

Knowledge Assessment Complete before co-teach



Pass Written Test

Minimum 85% correct • at least 1 month before co-teach

Pass a written test on material needed to teach a Reiki I, II, Reiki Master, and Karuna Reiki® class according to the ICRT's guidelines and your knowledge of other related information concerning Reiki. For any incorrect answers, you will need to correct them to 100%. The Program Director administers this test about a month before you co-teach.



Write and Submit a Paper

1,500-2,000 words • double-spaced • 12-point type

Write a paper on the Reiki subject of your choice. See Guidelines for writing your paper in this manual.

Review a Class Complete before co-teach



Review a Reiki I & II Class with Your Mentor

Pay FULL class tuition to Mentor • Recommended soon after acceptance into the LRMT program

Review a Reiki I & II class with your Mentor before co-teaching Reiki I & II. Your Mentor will submit documentation of your attendance and comments about your interactions with the other students. The Student Teacher will pay the FULL class tuition to the Mentor to review the Reiki I & II class.

FINAL STEP: Sponsor and Co-Teach a Reiki I & II Class with Mentor Teacher

Sponsor a Reiki I & II class and co-teach it with your Mentor Teacher. Be sure your Mentor Teacher informs all students who register for this class that it will be taught with you. This is the final milestone of the first licensing level.



Co-Teach Tuition Distribution

Fewer than 8 students

The Student Teacher must recruit a minimum of eight students. The Mentor Teacher receives tuition from the first eight students as compensation. If the class does not produce the required number, the Student Teacher must pay the balance from future class revenues.

More than 8 students

The full tuition goes to the Mentor Teacher, who pays all class-related expenses (books, travel, lodging, and classroom rent).

Tuition from additional students, minus expenses, is divided:

- 50% Student Teacher
- 50% Mentor Teacher

Note: The Student Teacher's licensing process is complete only when the full financial obligation has been met.

FINAL STEP: Completion Submission



Submit the Mentor Student Tracking Form for Reiki Level I - II

Upon completion of all requirements, submit the Mentor Student Tracking Form for Lv I - II to your Mentor and the Directors of the Licensed Reiki Master Teacher Training Program so they may verify your completion and have a record for your files.

Pay a monthly tuition/administrative fee of \$100 to the ICRT Licensing Program as an LRMT for Reiki I & II moving toward Reiki Master licensing. For partners, the fee is \$200.



Meet with Mentor Teacher Monthly

1 hour/month • by phone or online

You will discuss your progress in the program as well as one or more of the following: business comprehension and organization, technology, marketing, practitioner skills, teaching skills, healing issues that arise, or success consciousness. If more mentoring time is desired and agreed upon by the mentor and student teacher, the student teacher will pay the mentor directly at the ICRT rate for mentoring, prorated by time.



Complete the Mentor Student Tracking Form for Reiki Master

Send to Mentor Teacher monthly • Program Directors quarterly • by 10th of the month

Complete the Mentor Student Tracking Form for Reiki Master and send it to your Mentor Teacher monthly and the Program Directors quarterly by the 10th of the month. Before your co-teach, complete the report and send it to your Mentor and the Program Directors so they may verify you have completed all requirements.



Submit Progress Report

Teach a minimum of 3 Reiki Master classes, for a total of 9 or more as an independent teacher. Partners can teach separately or together, and each must teach 3 classes with 9 students. In co-taught classes, each teacher will count the class and the students.

If teaching ICRT Animal Reiki, you may count 1 class and up to 3 students.

Review a Class Complete before co-teach

Before teaching Reiki Master as a licensed teacher, the LRMT must review Master class with his or her mentor. When reviewing, it is necessary to do so from a future teaching perspective. Observing the Mentor Teacher's presentation will be helpful in this process. The LRMT pays full class tuition to the Mentor Teacher.



Role During Review

The reviewing LRMT should be introduced as an ICRT Licensed Reiki I & II teacher to the class. The LRMT is not there to co-teach, so he or she should be respectful of the Mentor Teacher, and the LRMT should at all times be in the role of a student.

However It would be appropriate for the Mentor Teacher to ask the other LRMT if he or she has anything to add during the informational parts of the class.

The LRMT must retake the symbols test and submit it as proof of review.

FINAL STEP: Co-Teach Options for ICRT Licensing Two pathways available

1 Option 1 • Student Teacher Sponsors the Class

The co-taught class can be sponsored by the Student Teacher, and the Mentor Teacher will travel to the Student Teacher's location for an in-person class or attend online for an online class.

Advertising: The mentor will advertise the class on www.reiki.org. Any additional advertising is the responsibility of the Student Teacher.

Minimum Students: The class must have an four-student minimum, and guarantee students fees for four students. Or eight students if mentor has to travel.

Payment Deadline: Any fees due must be paid to the Mentor Teacher within three months of the class.

Licensing: The LRMT is considered licensed for Reiki Master when the fees are paid.

2 Option 2 • Mentor Teacher's Class

The second option is to be decided between the Mentor Teacher and the Student Teacher. The Student Teacher can co-teach with his or her Mentor Teacher by traveling to the Mentor Teacher's class for an in-person class or attend online for an online class.

Fees: No fee is paid to the Student Teacher, as he or she is not establishing the class.

Tuition: The Student Teacher must also pay the standard class tuition to the Mentor Teacher if this option is chosen.

Co-Teach Split: In the advanced level classes, the actual co-teaching must be on a shared basis, with each teacher presenting about 50% of the course material.

You will discuss your progress in the program as well as one or more of the following: business comprehension and organization, technology, marketing, practitioner skills, teaching skills, healing issues that arise, or success consciousness. If more mentoring time is desired and agreed upon by the mentor and student teacher, the student teacher will pay the mentor directly at the ICRT rate for mentoring, prorated by time.

Send to Mentor Teacher monthly • Program Directors quarterly • by 10th of the month

Before your co-teach, complete the report and send it to your Mentor and the Program Directors so they may verify you have completed all requirements.

Teach 3 Holy Fire® III Karuna Reiki® Master classes

3 classes • minimum 9 students total (average 3 per class)

The LRMT must teach 3 Holy Fire® III Karuna Reiki® Master classes with a minimum average of 3 students for a total of nine Holy Fire® III Karuna Reiki® Master students or more as an independent teacher. Partners can teach separately or together and each must teach 3 classes with 9 students. In co-taught classes, each teacher will count the class and the students.

Review a Class Complete before co-teach

Before teaching Holy Fire® III Karuna Reiki® as a licensed teacher, the LRMT must review Karuna Reiki® class with his or her mentor. When reviewing, it is necessary to do so from a future teaching perspective. Observing the Mentor Teacher's presentation will be helpful in this process. The LRMT pays full class tuition to the Mentor Teacher.



Role During Review

The reviewing LRMT should be introduced as an ICRT Licensed Reiki Master teacher to the class. The LRMT is not there to co-teach, so he or she should be respectful of the Mentor Teacher, and the LRMT should at all times be in the role of a student.

International Program Requirements

Excluding Canada • Licensed Reiki Master Teacher Training – At a Glance

1 Attend the Retreat First

Required before you can apply

Attend the ICRT Retreat in person or online before applying.
Teachers already in the program must attend the retreat **every other year**.

Exceptions

1. Register for the next retreat & pay a deposit – but licensing is only finalized after you complete it.
2. Attend the Reiki Master or Karuna classes taught in Japan by William Rand & Colleen Benelli instead.
3. Other exceptions – ask the Directors.

2 Choose How You Co-Teach

Three ways – pick one per class

Option 1 • You Travel

You travel to the Mentor's class abroad and co-teach.

You pay:

1. Own travel & lodging
2. Own class fee to the Mentor

Option 2 • Mentor Travels

Mentor comes to your class abroad.

Mentor gets:

1. Own travel & lodging
2. 8-student fee (you pay the Mentor if **<8** sign up)
3. Reiki I&II: \$3000 or Master & Karuna: \$6000
4. 50/50 leftover split with you when **8+** sign-up

Option 3 • Online

Everyone joins by Zoom.

Reiki I & II: You organize the class

Mentor gets:

1. 8-student fee (you pay the Mentor if **<8** sign-up)
2. 50/50 leftover split with you when **8+** sign-up

Reiki Master & Karuna

Option A: Mentor organizes

You pay:

1. Own class fee to the Mentor

Option B: You organize

Mentor gets:

1. 4-student fee (you pay the Mentor if **<4** sign up)
2. 50/50 leftover split with you when **4+** sign-up

3 Other Requirements



Review Classes

Review the class for your Reiki level with your Mentor (online or in person) and pay the class fee to them.



Fees to Charge

Teaching outside the U.S.? Charge at the higher end for quality classes in your country.



Class Evaluations

Once in the program, you only need to translate the comments for evaluations rated 3 or less.



Psychological Evaluation

An hour-long interview with a counselor or psychologist. Questions are sent to you in advance.



Translator

If there's a language barrier, find a translator for paperwork, emails & mentoring. Cost is offset by a higher class price; the translator may also be a student and get a certificate.

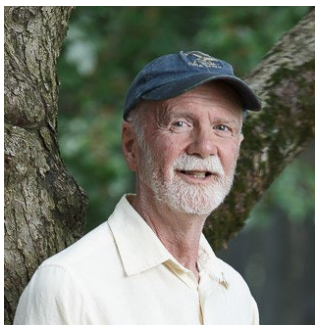

Dear Prospective ICRT-Licensed Reiki Master Teacher,

Thank you for your interest in the International Center for Reiki Training (ICRT) and our Licensed Reiki Master Teacher (LRMT)¹ Training Program. During the past several years, I have had the great pleasure of participating in the growth of the ICRT and am honored to be here to serve you as Executive Director along with my friends and colleagues, William Lee Rand, the ICRT staff, and our teachers.

I would like to take a moment to share with you a bit of my journey to Reiki, why I chose to become licensed by the ICRT, and my vision for our program and Reiki.

Since I was a small child, I have known that my Divine Purpose was to learn about and teach healing in ways that our society had not yet accepted as valid; I deeply felt this to be my mission and had the passion for pursuing this. When I met William Rand and became familiar with the ICRT, I realized that assisting in the growth of the ICRT was to be one way I would accomplish my mission in this life. PROGRAM INTENTION

We offer the LRMT Training Program as an advanced course of study for Reiki Masters who wish to teach the programs offered by the International Center for Reiki Training and would like to benefit from this affiliation with the ICRT as an ICRT LRMT.

This program is self-paced and will take a minimum of 1,000 hours to complete. The Student Teacher is encouraged to allow sufficient time to benefit from the process. An important part of the ICRT's Philosophy encourages ***"Placing greater value on learning from experience and inner guidance than on the teachings of an authority."*** This program helps the participant develop the confidence and skill to do this effectively.

The program intends to assist the Reiki Master Teacher in developing his or her spiritual connection to the source of Reiki, deepening understanding of Reiki, learning new Reiki techniques, developing one's skill level, and gaining sufficient personal experience to serve effectively as a teacher for others. This process is both an educational and healing experience for those who make the commitment.

There are many schools and styles of Reiki taught in the Reiki community, and we acknowledge that each Reiki student has the right to study, practice, and teach any style he or she chooses. At the same time, we know that because there is no single organizing body for the practice of Reiki, there are many differences in how and what is taught and practiced by the various schools and styles. While this provides the freedom to develop and innovate, which is necessary if the practice of Reiki is to improve, it also prevents the establishment of minimum standards by which all schools and styles operate.

Because of this, the ICRT considers setting high standards for itself and providing well-organized classes and well-researched, well-written class materials among its most important values. To achieve this purpose, William Lee Rand has made four research trips to Japan to visit sacred Reiki sites, interview Japanese Reiki teachers and researchers, and attend Reiki classes. These research trips took place in September 1997, October 1999, November 2001, and October 2016. In addition, he makes it a point to stay in touch with the teachers of various schools and styles of Reiki to remain abreast of new discoveries and developments in the field. He also has a strong source of spiritual guidance from which he gains inspiration and direction for the operation and development of the Reiki programs within the ICRT.

Each teacher entering our program brings his or her own teaching style, shaped by the teacher's unique background. We honor and value this. However, we require our teachers to offer, at a minimum, all the elements of our curriculum in their classes. This requirement ensures that students will receive consistent training regardless of which of our teachers with whom they choose to study. We have also developed our Code of Ethics and require all of our teachers to comply with its precepts.

The most challenging part of managing this program is selecting applicants. We receive applications from many Reiki Masters, but our program can accommodate only a few new teachers each year.

GOALS AND PURPOSE OF THE LICENSED REIKI MASTER TEACHER TRAINING PROGRAM

The purpose of the LRMT Training Program is to produce teachers of the highest caliber to represent and pursue the goals of the ICRT in a professional manner.

Toward this end, the International Center for Reiki Training is committed to:

1. Maintaining professional standards by providing:

- A professional level of credentialing to allow the ICRT to continue to provide a Certificate of Completion for health professionals.
- A training ground for Student Teachers to learn from experienced mentors while developing a thorough understanding of Reiki through sufficient personal experience.
- Qualification and review procedures to ensure that the teachers completing the program are emotionally balanced, cooperative rather than competitive, ethical, business-savvy, and effective as teachers.
- An effective, rational Code of Ethics to ensure that all our teachers operate in integrity and in the highest possible way to serve others.

2. Providing opportunities for growth among Senior Teachers by:

- Promoting growth among our Senior Licensed Teachers as they serve as mentors while assisting Student Teachers.
- Providing opportunities for Senior Teachers to participate more actively in the ICRT in terms of updating manuals, writing articles, creating professional conferences, and more.

3. Providing quality teaching materials and ongoing teacher training by:

- Having our Licensed Teachers assist in the development of new classes and training materials. They promote the ongoing development of a standardized, organized, and consistent teaching method, as outlined by the ICRT, incorporating the best suggestions from our teachers.
- Incorporating the latest research, techniques, and findings into the ICRT classes.
- Promoting the health and wellness of our teachers physically, mentally, emotionally, and spiritually by encouraging a healthy diet and exercise, daily self-Reiki, the use of the Holy Fire® Reiki energy in all areas of one's personal life, and a balanced lifestyle.

4. Sharing with each other new skills in the following areas: business comprehension and organization, technology, marketing, teaching skills, practitioner skills, healing issues that arise, and success consciousness.

5. Creating a community of Reiki teachers who support one another in the continuing process of advancing the highest ideals of Reiki and the ICRT.

ICRT REIKI MEMBERSHIP ASSOCIATION CODE OF ETHICS

1. **Confidentiality:** No information about the client will be disclosed to any third party without the written consent of the client, or the parent or guardian if the client is under the age of 18.
2. **Transparency:** Include on your website and be willing to explain to prospective clients or students your training background, what takes place in a Reiki session, the subjects covered in your classes, the amount of time spent in sessions and classes, and the fee charged.
3. **Integrity:** Be honest in all your activities and communication.
4. **Support:** Have a friendly, positive regard toward your clients and students and openly encourage them to heal and to do the best job possible with their Reiki practice and teaching program.
5. **Respect:** Value your clients and students and treat them with respect. Never engage in any illegal or immoral activity with your clients or students. Never touch their genital area or breasts, never ask them to disrobe and never make sexual comments, jokes, or references. Abstain from the use of drugs or alcohol during all professional activities.
6. **Honor:** Honor all Reiki practitioners and teachers, regardless of lineage or organizational affiliation. Refrain from making negative statements about other Reiki practitioners or teachers.
7. **Educate:** Inform your clients and students about the value of Reiki sessions and that they do not provide a cure and are not a substitute for care by a licensed health care provider.
8. **Refer:** Acknowledge that Reiki works in conjunction with other forms of medical or psychological care. If a client or student has a medical or psychological condition, suggest that they see a licensed health care provider, in addition to giving them Reiki sessions.
9. **Non-Interference:** Never diagnose medical or psychological conditions or prescribe medications. Never suggest that a client change or end dosages of substances prescribed by other licensed health care providers or suggest that the client change prescribed treatment. Never interfere with the treatment of a licensed health care provider.
10. **Honesty:** Never use another person's copyrighted material in your classes, website, or literature without having written permission before using and without giving credit.
11. **Freedom:** Encourage your students to use their inner guidance in determining who to take classes from, including the possibility of studying with more than one teacher.
12. **Professional Conduct:** Always act in such a way to create and maintain a professional image for the practice of Reiki and the ICRT Reiki Membership Association.
13. **Development:** Be involved in the continuing process of healing yourself on all levels to fully express the essence of Reiki in all that you do. Be in agreement with and work toward fully expressing the Usui Ideals and the ICRT Center Philosophy.
14. **Gratitude:** Be grateful for the gift of Reiki and for each client and student who chooses to come to you.

ICRT REIKI MEMBERSHIP ASSOCIATION STANDARDS OF PRACTICE

1. Use ICRT manuals when teaching your classes. Supply one manual per student. Manuals must be purchased from *www.reikiwebstore.com*.
2. Professional Members supply the RMA certificates for your students. Once licensed for a level, supply the LRMT certificates for your students.
3. Professional members use the title of Professional Member of the RMA or Professional Member of the Reiki Membership Association in their advertising and literature.
4. Reply to all Reiki related emails and voice mail in a timely way.
5. Use a Reiki Client Information Form and Reiki Documentation Form in your Reiki sessions.
6. Create a safe, comfortable, harmonious space for your sessions and classes.
7. All training and class Placements and Ignitions may be given in person or online.
8. When teaching Reiki classes, use only the RMA Reiki symbols as drawn by Mrs. Takata for Reiki II, the Master Practitioner symbol, and the Holy Fire® symbol for Master, which are located in the Reiki Master manual. Use the Karuna Reiki® symbols located in the Karuna Reiki® Master manual. No symbols are taught in Reiki I.
9. Include time for lecture, discussion, demonstration, practice time, and questions and answers in all your classes.
10. It is preferred that you teach Reiki I & II together as one class and that students take both classes.
11. In the Usui/Holy Fire® classes, ART and Master are now being taught together as one class called Reiki Master.
12. Require that a student has practiced at the Reiki II level for a minimum of six months before taking Reiki Master.
13. Use the RMA class outlines. Additional topics can be taught at the teacher's discretion.
14. Minimum class times: The lower number is for small classes of 1-3 students. Longer class times are for larger classes.
 - Reiki I—5-8 hours
 - Reiki II—5-8 hours
 - Reiki Master—15-24 hours
 - Karuna Reiki® Master—15-24 hours
15. When listing your Reiki training and qualifications in a biography or CV, include the fact that you have completed the Licensed Reiki Master Teacher Training Program with the International Center for Reiki Training. When advertising Reiki classes, include the fact that you will teach as a Licensed Reiki Master Teacher in accordance with ICRT guidelines. State that the ICRT issues Reiki certificates. If any classes are not ICRT licensed, use an asterisk to mark those classes and include “*not ICRT Licensed” on the same page. This indication applies to classes for which you are not yet licensed.

BENEFITS OF BEING AN ICRT LICENSED REIKI MASTER TEACHER

1. Membership in a support network that includes the staff of the International Center for Reiki Training and the other ICRT Licensed Reiki Master Teachers.
2. Being able to offer a Certificate of Completion for potential Continuing Education Credits to students in your class who are licensed as health professionals.
3. Your classes will be listed in the *Reiki News Magazine* and on www.reiki.org, which receives 7000 visits a day to its home page. Your name and contact information are also listed on the Reiki Membership Association (RMA) website. Many teachers find that becoming a Licensed Teacher increases their class enrollments by 100% or more.
4. Listing of your email, website, and phone number in the *Reiki News Magazine* for students to contact you about class information directly.
5. Use of the ICRT database to keep track of your students.
6. Use of the ICRT's LRMT logo in your advertising.
7. Association with a professional organization that is respected and has international recognition.
8. Having an advanced credential that demonstrates your commitment to your professional Reiki practice.
9. LRMT recognition through your listing on the www.reiki.org website.
10. Belonging to an established community of Reiki teachers who support one another in the continuing process of advancing the highest ideals of Reiki and the ICRT.
11. Having a mentor to guide you and the full support of the ICRT and all its resources. The Student Teacher and Mentor will meet to determine if the relationship is a good match.
12. The curriculum includes the following: business comprehension and organization, marketing, technology, teaching skills, practitioner skills, healing issues that arise, and success consciousness. Your mentor will guide you in these areas or assist you in finding resources for you to learn on your own. Different mentors have varying skill sets, and the Program Directors will do their best to match you with the appropriate mentor. Your mentor also guides you through the program's requirements.

AN OVERVIEW OF THE APPLICATION PROCESS

To verify that you meet the requirements to apply to the program, **your first step will be to complete the Licensed Reiki Master Teacher Program Questionnaire and pay an administrative fee of \$100.** For two people planning to teach together, the fee remains \$100. This Google form is available online at <https://forms.gle/mPxmb9xKdPp2uFTG7>. You will receive a response to your questionnaire and be notified if you are invited to apply. Contact Tammy@reiki.org to pay the fee.

Once invited to apply, you will complete the Google form containing the Letter of Intention, Application, and Applicant's Consent and Release, and pay the \$500.00 application fee. For two people planning to teach together, the fee remains \$500. The fee is valid for up to one year. After that time, the applicant will need to begin a new application and pay the fee again. **Contact Tammy@reiki.org to pay the fee.** The form is available at: <https://forms.gle/cCXo3fzWfw7NZQNK6> You may also see these forms beginning on page 36. If you move on to the next step, you will complete all your Reference Letters. The Co-Director will email you a link to the Google form that you will then email to your references.

The requirements for entering the Licensed Reiki Master Teacher Training Program are as follows. The requirements are listed in a checklist format. Upon completion of the checklist, you will have fulfilled all the requirements to be considered for admission into the Licensed Teacher Training Program.

The Directors of the Licensed Reiki Master Teacher Training Program will evaluate your application upon receipt of all required submissions. After we thoroughly review your application and contact your references, we will advise you of your status. If you are accepted into the program, you will next be asked to fulfill the requirements of the Licensed Reiki Master Teacher Training Program.

Also, Student Teachers who are accepted into the program will be assigned an ICRT LRMT Mentor Teacher. The Directors of the Licensed Teacher Training Program make this assignment with input from the Student Teacher. This Mentor Teacher will be a valuable resource for you as you progress through the licensing program.

In addition, as part of your training to be licensed in Reiki I and II, you are required to have 5 clients complete a Client Review Form. Ask the Program Director for this Google form.

To remain active in the program, you are to email a monthly progress report on the Mentor Student Tracking Form to your Mentor Teacher by the 10th of the month. This procedure helps ensure that the applicants we have selected to hold the Student Teacher slots are committed to and actively completing the program requirements. Email the Mentor Student Tracking Form and a Progress Report to the Program Directors every three months by the 10th of the month.

Next, you will find the requirements that need to be fulfilled to teach the advanced-level courses once you become an LRMT. You will find the Professional Contract that you will sign upon acceptance and all the additional forms needed for your application process in the back of this manual.

REQUIREMENTS TO APPLY TO ENTER THE ICRT LICENSED TEACHER TRAINING PROGRAM

1. Be at least 21 years of age.
2. Always professionally conduct yourself and maintain a clean, neat, professional appearance, including dress, during all professional activities.
3. Conduct yourself in a respectful manner on social media and all other online activities.
4. Be a teaching Reiki Master for a minimum of two years who has taught a minimum of eight (8) classes before applying.
5. Complete the most current version of the ICRT Usui/Holy Fire® Reiki I & II, Usui/Holy Fire® Reiki Master, and Holy Fire® Karuna Reiki® Master training with an ICRT Licensed Reiki Master Teacher.
6. Have attended online or in-person the International Reiki Retreat and participated in the Licensed Teacher meeting to acquaint you with the other Licensed Reiki Master Teachers and the benefits of the program. An exception may be made if the applicant has registered for the next retreat and paid a deposit. However, no licensing will be complete until after attending the retreat. Another exception is attending the Reiki Master or Karuna classes taught in Japan by William Rand and Colleen Benelli, which can qualify for the retreat requirement.
7. Have a current Reiki practice in which you are doing a minimum of 10+ sessions a month.
8. Agree with ICRT's Philosophy and Purpose.
9. Agree to honor and abide by the Code of Ethics and Standards of Practice set by the International Center for Reiki Training.
10. Trust Reiki energy to always provide the perfect healing result for the highest good of all concerned. Place no expectations or limitations on Reiki, and serve simply as a pure and open channel for the energies to flow through, with no attachment to the results.
11. Be actively working on your healing and personal growth.
12. Submit your Letter of Intention following the outlined guidelines in the application section found later in this document. It is available on the application Google Form. Ask the Program Director for the link.
13. Submit copies of your certificates by email to the Program Directors. Also, submit a copy of any non-ICRT Reiki Master's lineage.
14. Have the required Reference Letters completed through the Google form. Ask the Program Director for the link. References include an employer, a personal reference, three clients, five students, and your Reiki Master Teacher(s).
15. Complete an hour-long interview with a counselor or psychologist, which will occur towards the end of your application process. The questions will be given in advance.
16. Pass a background and credit check.
17. Pay a non-refundable application fee of \$500.00 with your Letter of Intention and application.

Complete the application within 5 months of submitting the questionnaire. If you need longer, make a request. The application fee will be valid for up to one year. After that time, the applicant will need to begin a new application and pay the fee again.

18. Be a Professional Member of the Reiki Membership Association for a minimum of one year.
19. Have a computer and a website. Be proficient with Word, be able to attach documents to an email, and access and store documents in the cloud. Answer emails within 48 hours.
20. Have taken Holy Fire® III Online training and be able to teach Reiki classes online.
21. Complete a business assessment through a Google form so that we may determine that you have the requirements to apply. Ask the Program Director for the link.

REQUIREMENTS TO MAINTAIN/FULFILL UPON ACCEPTANCE INTO THE LRMT TRAINING PROGRAM

CHECKLIST

Through All Levels of Licensing

1. Maintain your Professional Membership in the Reiki Membership Association during your licensure process.
2. Have a current Reiki practice in which you are doing a minimum of 10+ sessions a month.
3. Conduct yourself in a respectful manner on social media and all other online activities.
4. Agree with ICRT's Philosophy and Purpose.
5. Contract to honor and abide by the ICRT's Code of Ethics and Standards of Practice.
6. Always professionally conduct yourself and maintain a clean, neat, professional appearance, including dress, during all professional activities.
7. Trust Reiki energy always to provide the perfect healing result for the highest good of all concerned. Place no expectations or limitations on Reiki and serve simply as a pure and open channel for the energies to flow through, with no attachment to the results.
8. Be actively working on your healing.
9. Agree to charge the ICRT fee for each level for which you are licensed. Prior to being licensed, you are free to choose the fee you wish to charge.
10. Receive the upgrades for Holy Fire® Reiki to teach the most current version. This requirement is necessary, so you and your mentor are teaching the same version of Reiki for the class review and the co-teach.
11. During the co-teach, the Mentor and Student Teacher need to use the same outline so that all subjects are covered.
12. Professionally edit, before using for class, any PowerPoint presentations.
13. The Student Teacher and Mentor will decide together whether the class review and co-teach will be in person or online.
14. If the Student Teacher wishes to count ICRT Animal Reiki classes as part of the teaching requirements, the classes must have been taken with a LRMT.

15. Send your class roster and evaluations from each class to your mentor within seven days after class. Send your class roster and evaluations from each class you are you licensed for to eval@reiki.org within seven days.
16. It normally takes a Student Teacher one year to complete each level of licensing. However, Student Teachers may progress faster if they wish. Suppose a Student Teacher completes all levels in less than two and a half years. In that case, the Student Teacher will continue to receive mentoring from their Mentor Teacher or another Mentor Teacher of their choice for two and a half years from the start of their acceptance into the program. The \$100 fee will be paid directly to the Mentor Teacher for one hour of mentoring a month.
17. For partners, both must meet all the requirements for each level before either is licensed for the level.
18. Fines for Declined Credit/Payment Cards: The ICRT office handles payments for student fees, mentoring fees, certificates, etc. Fines will be assessed on any declined payment cards occurring within a rolling 12-month period, beginning with the date of the first such incident, as follows:
 - First decline: no charge
 - Second decline within 12 months: \$25
 - Third decline within 12 months: \$50
 - Fourth decline within 12 months: \$100 and a 3-month suspension from the program

Definition of a Review Student

A student who has taken that same level of class with you previously, while you were licensed for that level, and is now reviewing your class is considered a Review student by the ICRT. (This also assumes you originally paid the Student Fee for that student.) If marked correctly on the website as a “Review” student, you will not be charged the Student Fee, and they will not receive the Student Reiki News subscription. To clarify further, if that student took the class with you before you were licensed for that level, they would be considered a new student for the ICRT and would not be considered a Review Student.

The only exceptions are a current LRMT reviewing a class with another LRMT or a Mentor’s Student Teacher reviewing the class with them. These exceptions would be considered “Review” students, and no Student Fee is paid, no Student Magazine is given.

Any “Review” student is counted as a student for the LRMT’s Student Count.

**REQUIREMENTS TO TEACH USUI/HOLY FIRE® III REIKI I AND II
AS A LICENSED REIKI MASTER TEACHER**

1. Pay a monthly tuition/administrative fee of \$200 to the ICRT Licensing Program as a Student Teacher for Reiki I & II. For partners, the fee is \$300.
2. Meet with your Mentor Teacher two hours a month by phone or online. You will discuss your progress in the program as well as one or more of the following: business comprehension and organization, technology, marketing, practitioner skills, teaching skills, healing issues that arise, or success consciousness. If more mentoring time is desired and agreed upon by the mentor and the student teacher, the student teacher will pay the mentor directly at the ICRT rate, prorated by the time spent.
3. Complete the Mentor-Student Tracking Form for Reiki I & II and send it to your Mentor Teacher monthly and the Program Director quarterly by the 10th of the month. Prior to your co-teach, send the Mentor-Student Tracking Form for Reiki I & II to the Program Directors, so they can verify you have met all requirements.
4. Complete the Progress Report quarterly and send it to your Mentor Teacher and Program Director by the 10th of the month.
5. Teach six Reiki I & II classes, with a minimum average of three students each for a total of 18 or more students during the first year after acceptance into the program. Partners can teach separately or together, and each must teach six classes with 18 students. In co-taught classes, each teacher will count the class and the students. Each of these classes will be taught in accordance with the ICRT guidelines. ICRT symbol tests will be used and submitted to your Mentor, along with completed Class Reviews from each student in the class. Student Class Reviews will include the student's name and contact number, with their consent to be contacted by ICRT staff for monitoring of the class content, presentation, and their experiences with you as a Reiki Teacher. If the Student Teacher is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
6. Complete the paperwork for each class accurately for a minimum of four of the six classes taught.
7. Complete 100 Reiki treatments (after acceptance into the LRMT program) and submit documentation of each using the ICRT Reiki Treatment Documentation Form. "Complete" is defined as a 45-minute session with Usui/Holy Fire® III Reiki for an individual or a group. The treatments may also include the Healing Experience, other Experiences in the manuals, and Karuna Reiki®. A minimum of 10 of these sessions must be self-sessions, while the remaining 90 may be distant or in-person sessions. Of the 90 sessions, 30 may be animal Reiki sessions. Animal sessions may be shorter than 45 minutes and can include the caregiver. Send the completed forms to your mentor monthly.
8. Have five different clients submit reviews of the Reiki treatment they received from you. Ask the Program Director for the link to the Google form.
9. Pass a written test on material that you need to know to teach a Reiki I, II, Reiki Master, and Karuna Reiki® class according to the ICRT's guidelines and your

knowledge of other related information concerning Reiki. This test must be passed with at least a 85% correct score at least a month before your co-teach. For any incorrect answers, you will need to correct them to 100%. Jill Thiel administers this test about a month before your co-teach.

10. Write a paper on the Reiki subject of your choice with a minimum word count of 1500 and a maximum of 2000 on double-spaced pages (12-point type). See Guidelines for writing your paper in this manual.
11. Review a Reiki I & II class with your Mentor before co-teaching Reiki I & II. Your Mentor will submit documentation of your attendance and comments about your interactions with the other students. The Student Teacher will pay the FULL class tuition to the Mentor to review the Reiki I & II class. It is recommended that you review Reiki I & II soon after acceptance into the LRMT program.
12. Sponsor a Reiki I & II class and co-teach it with your Mentor Teacher.

(Be sure that your Mentor Teacher informs all students who register for this class that it will be taught with you.)

13. Upon completion of the first level of licensing and becoming a Licensed Reiki Master Teacher with the International Center for Reiki Training for Reiki I & II, the Student Teacher agrees to sign the Professional Contract.
 - The Mentor Teacher will advertise the class on *www.reiki.org*. Any additional advertising is the responsibility of the Student Teacher.
 - The Student Teacher must recruit a minimum of eight students. The Mentor Teacher will receive tuition paid by the first eight students as compensation for mentoring and co-teaching the class. If the class does not produce the required number of students, the Student Teacher must pay the balance of the required student tuition to the Mentor Teacher from future class revenues. The Student Teacher's licensing process is complete when the full financial obligation has been met.
 - The full tuition goes to the Mentor Teacher, but the Mentor Teacher pays all class-related expenses (i.e., books, travel, lodging, and classroom rent).
 - If more than the minimum number of students are recruited, the tuition, minus expenses from the additional students, is to be divided as follows: 50% to the Student Teacher and 50% to the Mentor Teacher.
 - In the co-taught class, the Student Teacher and Mentor Teacher will share the presentation, and the Mentor Teacher will add information, as necessary. It is optional for the Student Teacher to teach a greater share of the class, as agreed between the Student Teacher and Mentor Teacher. At all times, the Mentor Teacher will support the Student Teacher. If the information presented needs to be corrected, the Mentor Teacher will counsel the Student Teacher at break time and let the Student Teacher correct it with the class.
 - The Mentor Teacher will submit the Co-Teach Review Form on the Evaluation Form to the Program Director, reporting on all aspects of the teaching weekend.
 - Mentor/Student Teacher Co-Teach – The Mentor chooses the Student Teacher as

their “Co-Teacher” when setting up the class on the website. (The Student Teacher should NOT be listed as a student for the class.) The first time the Mentor schedules a Co-Teach with the Student teacher (Reiki I/II), an email must be sent to tammy@reiki.org. The office will then obtain the Student Teacher’s signature in preparation for the class certificates, which will include both teachers’ signatures. Once the Mentor LRMT pays the registration fees, the office will prepare the certificates in the same way they prepare International Certificates. Completed certificates with both signatures will be sent to the Mentor LRMT during the week following payment of the registration fees. (Remember the office completes class paperwork on Tuesdays, and then information is given to the staff for creating certificates.)

- When the Student Teacher is licensed for Reiki I and II, the teacher will pay the following fees for Reiki I and II classes: an advertising fee for classes on the website and in the Reiki News Magazine, student fees, certificate fees, and a magazine subscription for each student. For current fees, see the LRMT Manual in your membership's LRMT Forms and Info section on Reiki.org. When licensed for Reiki Master and Karuna, the teacher will pay the same fee categories for those levels. Additionally, the teacher must attend the ICRT Reiki Retreat, either online or in person, every other year.

Alternative to Sponsoring a Class

In RARE circumstances, it may be acceptable for the Student Teacher to travel to the Mentor Teacher and co-teach a class the Mentor Teacher has established. If done, the Student Teacher must pay full tuition to the Mentor Teacher. **This exception must be approved in writing by the Director of Teacher Licensing at least six months before the class to be co-taught.**

Completion of Requirements

Upon completion of all requirements, submit the Mentor Student Tracking Form for Reiki I & II to your Mentor and the Directors of the Licensed Reiki Master Teacher Training Program so they may verify your completion and have a record for your files.

The maximum time from acceptance into the Licensed Teacher Program until completion of all Reiki I & II requirements is two years.

Reasons for Denying Completion of a Level Up to and Including Being Asked to Leave the Program

One of the most important aspects of the LRMTTP is that a Student Teacher be trainable. Is the Student Teacher willing to listen to the Mentor, receive the training, and implement some suggestions? Is the Student Teacher continually making excuses to stay stuck? Does the Student Teacher have the requirements to apply for the program, or did something important

get missed in the application process? Is the Student Teacher progressing toward the requirements for the current level? The ICRT understands that life events can cause delays. Should such an event occur, the Mentor, Student Teacher, and Directors will discuss and consider whether to continue or take a one-to-three-month break from the program. If all parties agree to a break, the program fees will be waived, and any requirements fulfilled during this time will not count.

The application fee is valid for up to one year after the directors receive the students' application.

If the Student Teacher freezes their application after acceptance into the program, all mentoring and associated fees will discontinue upon the Student Teacher's notice to the Directors. If the Student Teacher decides to restart their training, they will meet with the Directors to discuss, assess, and determine their readiness to proceed with the program. The Directors will make the final decision. If the Student Teacher does reenter the program, their Mentor will be re-established, and all fees will be reinstated. The student teacher may freeze their training for up to one year, and exceptions will be determined by the Directors.

If the Student Teacher takes more than 2 years to complete licensing for Reiki I and II, or more than 4 years to complete licensing through Karuna, the Student Teacher may be asked to leave the program.

Throughout the program, Student Teachers must maintain consistent, accurate, and timely completion of paperwork and payment of fees. If a Student Teacher encounters issues with paperwork or fee payments more than three times during a level, they will be suspended for three months. After this period, the Student Teacher may resume the program.

GUIDELINES FOR WRITING YOUR REIKI PAPER FOR LICENSING

- The paper should be about Reiki and include little about other topics.
- Strive to create a paper that could be published in the *Reiki News Magazine*. Read the *Reiki News Magazine* for ideas about topics and quality of writing. Also, check out the writer's guidelines at <https://www.reiki.org/reiki-news-magazine-writers-guidelines>.
- We have adopted the following information from the writer's guidelines on reiki.org that addresses AI content: We check each submission for plagiarism and AI-generated text. Authors should not rely on artificial intelligence to generate entire content sections. Articles should reflect the author's genuine thoughts, beliefs, and experiences. We reserve the right to reject articles that appear to depend on AI-generated content excessively. To maintain the quality and integrity of our publication, our editors may request clarification on how you used AI in the writing process.
- Share how you have used Reiki to address a topic, i.e., Reiki for stress, Reiki for personal growth, Reiki for depression. Or write an inspirational article about Reiki. Or write about a technique you have used for a period of time and tested out with many clients.
- Include endnotes with references for your information, which can include resources such as quotes from books, information from clients, or client stories (with written permission), or information from the web that augments your article.
- Edit your paper for grammar or have a professional editor do this.
- The paper should be 1500 to 2000 words typed in a 12-point font.

REQUIREMENTS TO TEACH ADVANCED LEVEL REIKI CLASSES AS AN LRMT

Requirements to Teach Usui/Holy Fire® III Reiki Master Level

1. The LRMT must teach a minimum of six Reiki I & II classes as a Licensed Reiki Master Teacher within a year. Each class should have a minimum average of three students for a total of 18 or more students. Partners can teach separately or together, and each must teach six classes with 18 students. In co-taught classes, each teacher will count the class and the students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
2. The LRMT must teach a minimum of three Reiki Master classes, with a minimum average of three students, for a total of nine students or more as an independent teacher. (The ICRT won't advertise or issue certificates for the Reiki Master class, but you should be teaching these levels independently to gain experience.) Partners can teach separately or together, and each must teach three classes with nine students. In co-taught classes, each teacher will count the class and the students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count one class and up to three students from their Animal Reiki Master classes.
3. Pay a monthly tuition/administrative fee of \$100 to the ICRT Licensing Program as an LRMT for Reiki I & II, moving toward Reiki Master licensing. For partners, the fee is \$200.
4. Within three years of acceptance into the program, you must have completed the requirements to be licensed for Usui/Holy Fire® Reiki Master. Note that the usual time is two years.
5. Meet with your Mentor Teacher by phone or online one hour per month. You will discuss your progress in the program as well as one or more of the following: business comprehension and organization, technology, marketing, practitioner skills, teaching skills, healing issues that arise, or success consciousness. If more mentoring time is desired and agreed upon by the mentor and the student teacher, the student teacher will pay the mentor directly at the ICRT rate, prorated by time.
6. Complete the Mentor Student Tracking Form for Reiki Master and send it to your Mentor Teacher monthly and the Program Directors quarterly by the 10th of the month. Before your co-teach, complete the report and send it to your Mentor and the Program Directors so they may verify you have completed all requirements.
7. Complete the Progress Report quarterly and send it to your Mentor Teacher and Program Directors quarterly by the 10th of the month.

Before teaching Reiki Master as a licensed teacher, the LRMT must both review and co-teach Reiki Master. When reviewing, do so from a future-teaching perspective. Observing the Mentor Teacher's presentation will be helpful in this process. The LRMT must review the class with the Mentor Teacher or, with the agreement of the Mentor and Directors, another Senior Licensed Teacher, before co-teaching the class.

When an LRMT reviews the Reiki Master class with a Mentor Teacher, he or she should be introduced to the class as an ICRT Licensed Reiki I & II teacher. The reviewing LRMT is not there to co-teach, so they should be respectful of the presenting teacher. The LRMT should, at all times, be in the role of a student. However, it would be appropriate for the Mentor Teacher to ask the other LRMT if he or she has anything to add during the informational parts of the class. The LRMT must retake the symbols test and submit it as proof of review. The LRMT pays the Mentor Teacher the full class tuition.

There are two options to co-teach the class for ICRT licensing. In the first option, the co-taught class can be sponsored by the LRMT, and the Mentor Teacher will travel to the LRMT's location for an in-person class or attend online for an online class. The mentor will advertise the class on *www.reiki.org*. Any additional advertising is the responsibility of the Student Teacher. The class must have a minimum of eight students, or guarantee students' fees for eight students if the Mentor must travel to the Student Teacher's class, or four students if no travel is required. Any fees due must be paid to the Mentor Teacher within three months of the class. The LRMT is considered licensed for Reiki Master when the fees are paid.

The second option is to be decided between the Mentor Teacher and the LRMT. The LRMT can co-teach with their Mentor Teacher by traveling to the Mentor Teacher's class for an in-person class or attending online for an online class. In this instance, no fee is paid to the LRMT, as he or she is not establishing the class. The LRMT must also pay the standard class tuition to the Mentor Teacher if this option is chosen. In advanced-level classes, co-teaching must be shared, with each teacher presenting about 50% of the course material.

Upon completion of all requirements, submit the Mentor Student Tracking Form for Reiki Master to your Mentor and the Directors of the Licensed Reiki Master Teacher Training Program so they may verify your completion and have a record for your files.

Requirements to Teach Holy Fire® III Karuna Reiki®

1. The LRMT must teach a minimum of six Reiki I & II classes as an ICRT Licensed Reiki Master Teacher. Each class should have a minimum average of three students for a total of 18 or more students. Partners can teach separately or together, and each must teach six classes with 18 students. In co-taught classes, each teacher will count the class and the students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
2. The LRMT must teach a minimum of three Reiki Master classes with a minimum average of three students for a total of nine students or more as an LRMT. Partners can teach separately or together, and each must teach three classes with nine students. In co-taught classes, each teacher will count the class and the students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count one class and up to three students from their Animal Reiki Master classes.
3. The LRMT must teach three Holy Fire® III Karuna Reiki® Master classes with a minimum average of three students for a total of nine Holy Fire® III Karuna Reiki® Master students or more as an independent teacher. Partners can teach separately or together, and each

must teach three classes with nine students. In co-taught classes, each teacher will count the class and the students.

4. Pay a monthly tuition/administrative fee of \$100 to the ICRT Licensing Program as an LRMT for Usui/Holy Fire® III Reiki Master licensing, moving toward Holy Fire® III Karuna Reiki®. For partners, the fee is \$200.
5. Within four years of acceptance into the program, you must have completed the requirements to be licensed to teach Holy Fire® III Karuna Reiki®.
6. Meet with your Mentor Teacher one hour per month by phone or online. You will discuss your progress in the program as well as one or more of the following: business comprehension and organization, technology, marketing, practitioner skills, teaching skills, healing issues that arise, or success consciousness. If more mentoring time is desired and agreed upon by the mentor and the student teacher, the student teacher will pay the mentor directly at the ICRT rate, prorated by time.
7. Complete the Mentor-Student Tracking form for Karuna Reiki® Master and send it to your Mentor Teacher monthly and the Program Directors quarterly by the 10th of the month.
8. Complete the Progress Report quarterly and send it to your Mentor Teacher and Program Directors quarterly by the 10th of the month.

Before teaching Holy Fire® III Karuna Reiki® as a licensed teacher, the LRMT must both review and co-teach Karuna Reiki®. When reviewing, do so from a future-teaching perspective. Observing the Mentor Teacher's presentation will be helpful in this process. The LRMT must review the class with the Mentor Teacher or, with the agreement of the Mentor and Directors, another Senior Licensed Teacher, before co-teaching the class. The LRMT must re-take the symbols test and submit it as proof of review. The LRMT pays the Mentor Teacher the full class tuition.

When the LRMT comes to the Mentor Teacher's class to review, he or she should be introduced as an ICRT Licensed Teacher. The reviewing LRMT is not there to co-teach, so he or she should be respectful of the Mentor Teacher, and the LRMT should at all times be in the role of a student. However, it would be appropriate for the Mentor Teacher to ask the LRMT if he or she has anything to add during the informational parts of the class.

There are two options to co-teach the class for ICRT licensing. In the first option, the co-taught class can be sponsored by the LRMT, and his or her Mentor Teacher will travel to the LRMT's location for an in-person class or attend online for an online class. The mentor will advertise the class on www.reiki.org. Any additional advertising is the responsibility of the Student Teacher. The class must have a minimum of eight students, or guarantee students' fees for eight students if the Mentor must travel to the Student Teacher's class, or four students if no travel is required. Any fees due must be paid to the Mentor Teacher within three months of the class. The LRMT is considered licensed for Holy Fire® Karuna Reiki® when the fees are paid.

The second option is to be decided between the Mentor Teacher and the LRMT. The LRMT can co-teach with their Mentor Teacher by traveling to the Mentor Teacher's class for an in-

person class or attending online for an online class. In this instance, no fee is paid to the LRMT, as he or she is not establishing the class. The LRMT must also pay the standard class tuition to the Mentor Teacher if this option is chosen. In advanced-level classes, co-teaching must be shared, with each teacher presenting about 50% of the course material.

Upon completion of all requirements, submit the Mentor Student Tracking Form for Karuna Reiki® to your Mentor and the Directors of the Licensed Reiki Master Teacher Training Program so they may verify your completion and have a record for your files.

You must complete all training through Holy Fire® III Karuna Reiki® within four years of acceptance into the program.

Karuna Reiki® is a registered trademark of the International Center for Reiki Training.

REQUIREMENTS FOR INTERNATIONAL PROGRAMS, EXCLUDING CANADA

Retreats

Applicants must attend the ICRT Retreat, either in person or online, before applying to the program. An exception may be made if the applicant has officially registered for the next ICRT retreat and has paid a deposit. However, no licensing will be finalized until after retreat completion. Teachers in the program are required to attend the ICRT Retreat every other year. Another exception is that students may attend the Reiki Master or Karuna classes taught in Japan by William Rand and Colleen Benelli in lieu of the initial retreat requirement. Other exceptions may be possible by contacting the Directors.

Review Classes

The Student Teacher is required to review the class appropriate for the Reiki class level they are working on with their Mentor Teacher online or in-person, and to pay the class fee to the Mentor Teacher.

Co-Teach

Option 1—The Student Teacher travels to the Mentor's class in the Mentor's country and co-teaches with the Mentor: The Student Teacher is required to pay their own travel and lodging expenses and also pay the class fee to the Mentor Teacher.

Option 2—The Mentor Teacher travels to the Student Teacher's class in a foreign country: The Mentor Teacher will receive the class fees for the first eight students. The Mentor Teacher's travel and lodging expenses will be paid, and in addition, the Mentor Teacher must receive a minimum of \$3,000 for Reiki I & II and \$6,000 for Reiki Master and Karuna Reiki® Master. Any money left over after the above fees have been paid will be split 50/50 between the Student Teacher and the Mentor Teacher.

Option 3—Class is held online using Zoom: The Mentor Teacher, the Student Teacher, the Translator if needed, and the students are all online.

Financial Details for Option 3

Reiki I&II - The Student Teacher will organize the class, and the Mentor Teacher will receive the class fee for the first eight students. If the class has fewer than eight students, the Student Teacher will pay the Mentor Teacher out of pocket for the additional class fee necessary to equal the fee for eight students. The class will be listed on the Student Teacher's website.

For Reiki Master and Karuna Reiki® Master, the Mentor teacher will organize the class, and the Student Teacher will pay their own class fee to the Mentor teacher.

Another option for Reiki Master and Karuna Reiki® Master is for the Student Teacher to organize the class. The fees for the first four students will be paid to the Mentor Teacher.

Translator

If there is an English language barrier, the applicant and student teacher must find a translator to assist with paperwork, emails, and mentoring sessions. If classes are taught in a language other than English, a translator will be included in the class. The translator's additional expense will be offset by increasing the class cost. The translator can also be a student and receive a class certificate.

Psychological Evaluation

The applicant will have an hour-long interview with a counselor or psychologist. The questions will be sent in advance.

Fees to Charge

When teaching ICRT classes outside of the United States, charge a fee for Reiki classes that is at the higher end for quality classes in your country.

Class Evaluations

Once in the program, the Student Teacher will only need to translate the comments for evaluations with a rating of 3 or less.

LRMT LEGACY PROGRAM

This program was established to provide existing LRMTs with an opportunity to mentor family members, spouses, partners, or close relationships to become LRMTs. The family member enters the LRMT program as a Legacy Student and is mentored by the LRMT.

We believe the Legacy Program will contribute to the future succession of Reiki.

The Legacy Program consists of the following criteria:

Legacy Student Requirements to apply:

- A LRMT mentor trains a family member, spouse, partner, or close relationship.
- Must be the legal age of 21 years old.
- The legacy student lives in the same community as the mentor. If they change location, they would move to the regular LRMT track.
- Teaches Reiki classes in the same space as the mentor.
- Obtains students from the same geographical regions and community.
- The background check is waived for the Legacy Program.

Legacy Program Requirements:

- The Legacy student directly contributes to all aspects of the mentor's Reiki business throughout their program.
- Must contribute to every part of the class development, including setup, paperwork before and after class, follow-up, marketing, registration, etc.
- The Legacy Student co-teaches Reiki classes with their mentor or may teach classes independently.
- The mentor signs the certificates for any classes co-taught until the student is licensed for each level. For classes, the Legacy student teaches independently prior to being licensed for each level, the Legacy student will generate the certificates through the Professional Member part of the ICRT website and sign them. The mentor will not sign these certificates because

the class is being taught independently.

Requirements to teach Usui/Holy Fire® III Reiki I and II

- Teach independently or co-teach six Reiki I and II classes, with a minimum average of three students each or a total of 18 or more students during the first year after acceptance into the program. If the Student Teacher is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
- Complete 100 Reiki treatments (**after** acceptance into the Licensing program) and submit documentation of each *using the ICRT Reiki Treatment Documentation form*.
- Have 5 different clients submit reviews of the Reiki treatment they received from you.
- Pass a written test over material you need to know to teach a Reiki I, II, Master, and Karuna class according to the ICRT's guidelines and your knowledge of other related information concerning Reiki.
- Write a paper on the Reiki subject of your choice with a minimum of 1500 and a maximum of 2000 words on double-spaced pages.
- Review a Reiki I and II class before co-teaching Reiki I and II.
- Co-teach Reiki I and II with your Mentor Teacher.
- Agree to stay up to date with the upgrades to Holy Fire® Reiki as they are available.
- Pay a monthly fee to the ICRT of \$50.

Requirements to teach Usui/Holy® Fire III Reiki Master

- The LRMT must teach independently or co-teach a minimum of six Reiki I & II classes. Each class should have a minimum average of 3 students for a total of 18 or more students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
- The LRMT must teach independently or co-teach a minimum of three Reiki Master classes with a minimum average of three students for a total of nine or more students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count one class and up to three students from their Animal Reiki Master classes.
- Review Reiki Master before the final co-teach for Reiki Master.
- Co-teach Reiki Master with your Mentor Teacher.
- Pay a monthly fee to the ICRT of \$50.

Requirements to teach Holy Fire® III Karuna Reiki®

- The LRMT must teach independently or co-teach a minimum of six Reiki I & II classes. Each class should have a minimum average of three students for a total of 18 or more students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
- The LRMT must teach independently or co-teach a minimum of three Reiki Master classes with a minimum average of three students for a total of nine or more students. If the LRMT is

teaching ICRT Animal Reiki, the teacher may count one class and up to three students from their Animal Reiki Master classes.

- The LRMT must teach independently or co-teach three Karuna Master classes with a minimum of nine students.
- Review Karuna before the final co-teach for Karuna.
- Co-teach Karuna with your Mentor Teacher.
- Pay a monthly fee to the ICRT of \$50.

LICENSED REIKI MASTER TEACHER TRAINING PROGRAM OVERVIEW

The Licensed Reiki Master Teacher Training Program (LRMTTP) is an advanced course of study for licensure as a Reiki teacher with the International Center for Reiki Training (ICRT). Applicants must apply and be accepted into the program before beginning training. The training requires approximately 1,000 hours of study and practice and usually takes 3-4 years to complete. The curriculum is designed specifically for Reiki Masters who wish to dedicate themselves to teaching and practicing Reiki on a higher professional level. Some of our teachers operate healing centers. All maintain an active Reiki practice and are committed to empowering others through Reiki. While each student teacher will be assigned a mentor to work with, our program is actually structured so each student teacher becomes an apprentice to the Reiki Energy itself. - Sponsor a Reiki Master class and co-teach it with your Mentor Teacher.
- Pay a monthly fee and other fees.

Requirements to teach Holy Fire® Karuna Reiki® at the current upgrade level

- The LRMT must teach a minimum of six Reiki I & II classes as a Licensed Reiki Master ICRT Teacher. Each class should have a minimum average of three students for a total of 18 or more students. If the LRMT is teaching ICRT Animal Reiki, the teacher may count two classes and up to six students from their Animal Reiki I & II classes.
- The LRMT must teach a minimum of three Reiki Master classes with a minimum average of three students for a total of nine or more students as an LRMT. If the LRMT is teaching ICRT Animal Reiki, the teacher may count one class and up to three students from their Animal Reiki Master classes.
- The LRMT must teach three Holy Fire® Karuna Master classes with a minimum of nine students as an independent teacher.

FINANCIAL COMMITMENT AND EARNINGS FOR THE LICENSED REIKI MASTER TEACHER TRAINING PROGRAM

This document gives an overview of the fees and income you can earn by becoming a student teacher in the Licensed Reiki Master Teacher Training Program. The fees are approximate because students progress through the 1,000-hour program at their own pace, usually taking one year per level. However, it is possible to complete the requirements more quickly, resulting in fewer fees. Most teachers actually exceed the teaching and session requirements, resulting in more income. You are also free to set your own fees for sessions and classes, so the income is approximate. After becoming licensed for a level, such as Reiki I and II, you will charge the ICRT fee for that level of class. You are always free to set your own session fee. Remember, becoming licensed will usually double your students through the power of advertising with the ICRT and your new business skills! After you are licensed, you only pay advertising fees for your classes (one time \$100 each), a per student fee (\$30 for I/II and \$55 for RM and Karuna), a gift magazine subscription for each student (\$20), a certificate fee per student (\$5), the manual price for each student, and your cost to attend the Reiki Retreat at least every other year.

Total Potential Earnings while working through the program: \$88,155 to \$116,955. This is approximate and could be more or less.

Net Income before your expenses: \$76,710 to \$105,510. You will incur expenses of your own choosing to earn this income, such as marketing, computers, and office supplies.

This Professional Contract is entered into between _____, Licensed Teacher, and the International Center for Reiki Training. The Licensed Teacher agrees to and states that he or she will abide by the following:

1. To maintain an active Reiki practice.
2. To always conduct myself in a professional manner, including what I post on social media.
3. To maintain a clean, neat, professional appearance and dress during all professional activities.
4. To promote harmony in the Reiki community.
5. To honor and respect students, encourage their independent growth, and freely share information with them.
6. To have email and voicemail/text to receive messages from the ICRT and to check both daily and respond within 48 hours or sooner based on the deadline given.
7. To meet deadlines for submission of teaching schedules for advertising in the *Reiki News Magazine* and the website.
8. To teach all Reiki classes according to ICRT guidelines, including material to be presented for each class.
9. To use ICRT-developed manuals for all classes (Available to LRMTs at 40% off the retail cost when ordered in groups of five or more).
10. To advertise only ICRT-published tuitions for each level I am licensed to teach. Tuition for international classes may be commensurate with other high-quality training in that country.
11. To adhere to the ICRT Standards of Practice, Code of Ethics, Center Philosophy and Purpose, and Social Media Policy.
12. To do Placements and Ignitions or attunements according to the ICRT methods.
13. To agree to be observed by the ICRT staff at any time teaching any level of class and agree that my students may be contacted by ICRT staff at any time for quality review.
14. To keep current my contact information that is published on the website and in the *Reiki News Magazine*, which includes a phone number and email address.
15. To pay current advertising fees established by the ICRT.
16. To pay student fees and certificate fees within seven days of class. These fees are included in

tuition paid to LRMT.)

17. To pay \$24 per student for a 1 yr. subscription to Reiki News. (Included in tuition paid to LRMT.)
18. To maintain up-to-date GDPR wording on my website.
19. To submit a roster and class reviews for each student to the ICRT within one week of the class.
20. To complete all levels of licensing through Karuna Master within 4 years of acceptance into the program.

Certificate Fee—A fee paid to the ICRT by the LRMT for the processing of certificates for each student who takes a class.

CEU/CE—Continuing Education Credits that massage therapists and other professionals can earn by taking Reiki classes.

Class Fee—A fee paid to the ICRT by the LRMT for each student who takes a class for support of the LRMT program.

Co-teaching—A step in becoming a Licensed Reiki Master Teacher in which you organize a class and share teaching responsibilities with your supervising teacher.

International Center for Reiki Training—(ICRT) is the organization that supports the Licensed Teacher Training Program.

ICRT Website—www.reiki.org.

Japanese Reiki Techniques—Techniques taught in the ICRT Reiki classes and includes the techniques of *Gassho*, *Byosen*, *Kenkyoku*, *Koki-ho*, *Jacki-Kiri Joka-ho*, *Enkaku Chiryō*, and *Gyoshi-ho*.

Karuna Reiki®—An advanced level of Reiki Training developed by the ICRT.

Licensed Reiki Master Teacher (LRMT)—Someone who has completed all the requirements to become a Licensed Reiki Master Teacher and is licensed to advertise and teach Reiki I & Reiki II classes with the ICRT.

Reiki News Magazine—A publication published by the ICRT four times a year that lists the classes you teach.

Reiki Practice—Is defined as one in which you see an average of 10–15 clients a month.

Reiki Retreat—A retreat sponsored by the ICRT and held once a year as a three-day weekend of workshops, meditations, and Reiki.

Senior Licensed Teacher—Someone who has been teaching as a Licensed Karuna Reiki® teacher for at least five years.

Mentor Teacher—Someone who has been teaching as a Licensed Karuna Reiki® teacher for two years, is proficient with paperwork, and is in good standing with the ICRT. For additional information, see the ICRT Licensed Teacher Training Mentor Manual.

Student Teacher—Someone who has been accepted into the Licensed Reiki Master Teacher Training Program and is in the process of completing the requirements to become a Licensed Teacher.
